Safe Sanctuary Procedures

Fremont First United Methodist Church (FUMC) adheres to a Safe Sanctuary policy that serves to protect your children and our volunteers. Please read the following procedures and sign your name to indicate your understanding and agreement. If you have any questions or concerns, please contact the FUMC office at 402-721-0817.

- Children must attend the appropriate age/grade level class. The children in each class must be that age/grade by as of August 26, 2009. Children do not move up to the next age class on their birthday, all children move up to the next level the first Sunday in September.
- Sign in/Sign out. Each child 2nd grade and below must be signed in and out by a parent. Children 3rd grade and above may sign themselves in and out of class.
- Sunday school classes may run up to 10 minutes longer than the service. Please be prompt in picking your child up but please do not interrupt a class in session if the door is closed.
- All our volunteers working with children have been screened and attended a training session including information on preventing child abuse. In addition, children should never be left alone with only one supervisor. The 2-person rule should apply in all rooms. If at any time you have any concerns about the care your child is receiving, please contact the children’s ministry staff or a pastor.
